1. These Terms of Use

These Trading Station Website Terms of Use set out the terms and conditions which apply when you access or use our site. These terms of use apply to all users of, and visitors to, our site, including all students and customers who register for or use our Trading Station platform to seek to purchase, sell or supply any products or services.

You must read these terms of use carefully before you access or use our site as these terms of use form a legal contract between you and us and contain important details about your and our legal rights and obligations.

By using our site, you confirm that you have read these terms of use and that you agree to be bound by them. If you do not agree to comply with these terms of use then you must not access or use our site.

We may suspend or withdraw or restrict the availability of all or any part of our site for any reason, including business and operational reasons. We will try to give you reasonable notice of any suspension or withdrawal.

5. Our site is only for users in the UK

Our site is directed to people residing in the United Kingdom. We do not represent, warrant or guarantee that content available on or through our site is appropriate for use or available in other locations.

6. How you may use content on our site

We are the owner or the licensee of all intellectual property rights in our site, and in the content published on it. Those works are protected by copyright laws and treaties around the world. All such rights are reserved.

You must not misuse our site by knowingly introducing viruses, trojans, worms, logic bombs or other material that is malicious or technologically harmful.
